

2020 HAYNIE OWNERS TOURNAMENT

BOAT GIVEAWAY

It is with a heavy heart we announce the cancellation of our 2020 Haynie Owners Fishing Tournament. Unfortunately, we are all aware of the seriousness of COVID-19 and the restrictions being set forth to ensure the safety of our community. Each year we devote countless hours to creating a bigger and better appreciation event for our owners, and we still want to give back to our owners this year. To make this possible, we have chosen to partner with the Hook Spit Junior Anglers Association (HSJAA) to give away a 2020 Haynie 23 Super Cat complete with a Mercury 250 Pro XS Outboard and Coastline Aluminum Trailer.

The Hook Spit Junior Angler Association's mission is to promote the sport of youth fishing, enable youth to become better students, anglers, and people while exposing them to all the opportunities that competitive fishing offers, and providing scholarships for continuing education. A portion of all proceeds from sale of raffle tickets will be donated to HSJAA to support all they are doing for our youth along the gulf coast. We are proud to sponsor this giveaway with HSJAA and encourage you to learn more about their organization online at www.hsjaa.com.

How It Works: The giveaway format will be comparable to tradition of the Haynie Owners Tournament. Raffle tickets will be available for purchase at \$100 per ticket beginning Monday, August 10th. (10) raffle tickets will be drawn to determine the finalists. All finalists will be invited to a small, private gathering at Chris's Marine in Aransas Pass where process of elimination will determine (1) winner to take home his/her brand new Haynie. Finalists and matching raffle ticket stub must be present to win.

Who can Buy: Tickets are only available to registered Haynie Owners and all purchases will be validated at time of entry. If a Haynie Owner authorizes a representative to purchase/pickup tickets on their behalf, the attached authorization must be signed and will be validated.

Where to Buy: Tickets can be purchased in person at Chris's Marine located at 1213 W. Wheeler Ave. in Aransas Pass, TX. Tickets may also be purchased online at www.chrismarineboats.com or www.hayniebayboats.com. While tickets may be purchased online, please note the physical raffle tickets must be picked up from Chris's Marine prior to stated deadlines to ensure the stubs are deposited into the official raffle depository.

What's included: For all raffle tickets sold for the boat giveaway, participants will be given (1) raffle ticket for additional door prizes as well as a Haynie buff. All tickets purchased prior to Friday, August 21st will be given a bonus raffle ticket for door prizes. Winners of the door prizes may claim items from Chris's Marine during normal business hours.

How to Win: A portion of the door prize drawings and the drawings for the (10) boat giveaway finalists will take place on Friday, September 11th beginning at 6:30 pm. All raffles drawings will be broadcasted live via the Chris's Marine and Haynie Boats Facebook page at facebook.com/chrismarineboats. Additionally, immediately following the drawings, all results will be posted to our websites at www.chrismarineboats.com and www.hayniebayboats.com. The remaining door prize drawings and final boat raffle will take place at 2:00 pm on Saturday, September 12th at Chris's Marine. Again, all finalists or an authorized representative must be present to win. Winner will be responsible for all tax, title, and license fees.

Deadlines: Deadline to purchase and deposit raffle tickets into the official raffle depository is 6:00pm on Friday, September 11th. Deadline for bonus door prizes tickets is 11:59 pm on Friday, August 21st.

Exceptions: To reach our proceed-sharing goals with HSJAA, we are requiring a minimum of 500 tickets to be sold prior to the drawing. However, to maintain comparable odds to last year's tournament, the maximum number of tickets sold will be 1,000. In the event we have not sold 500 tickets by Friday, September 11th, drawings for both the door prizes and boat giveaway will be postponed to a later date.

Refunds: All teams who signed up for the 2020 Haynie Owners Tournament prior to the tournament cancellation are entitled for a full refund of their registration fees. Each team will be contacted by a Chris's Marine staff member with the option to initiate a refund or transfer their funds paid for raffle tickets. No registration fees will be held for the 2021 Haynie Owners Tournament. All raffle ticket purchases are final.

Junior Bonus: Additionally, there will also be a special group of raffle items available to our Haynie Youth and Juniors, including an offshore fishing trip with Chris Coulter and his Deez Nautz Crew. Any Haynie Owners, regardless of participation in the boat raffle, may register children under the age of 18 for these drawings.

What's Next: The annual fishing tournament event and festivities are very important to us and we still hope to celebrate and showcase Haynie Pride with our first ever Haynie Boat Parade. Hoping this can bring our community together, while still abiding by COVID-19 restrictions and social distancing recommendations. All Haynie owners are invited, regardless of participation in the giveaway. The parade will take place on Saturday, September 12th at 4:00 pm, immediately following the boat giveaway, with our 2020 Haynie 23 Super Cat winner leading the pack! Parade will begin at Conn Brown Harbor in Aransas Pass; full route to be posted at a later date.
